Overview

End of the School Year Field Trip to SeaWorld Aquatica Water Park in Orlando, Florida for Kindergarten thru 12th Grade students. (Please Note: This trip is to a water park.)

Trip Itinerary

Trip Date - This Field Trip is scheduled for Friday, May 26, 2023. Students will travel by charter bus or school van from the school campus to SeaWorld Aquatica Water Park.

Departure Time - We will begin loading the charter bus and vans at 7:15AM and will be leaving the school campus promptly at 7:30AM. Students must be dropped off at the school campus by their parents between 6:45AM and 7:00AM, the morning of May 26, 2023. Students cannot ride the school bus to school the day of the trip.

Returning Time - We will return to the school campus at approximately 7:45PM, on May 26, 2023. Students must be picked-up from the school campus by their parent at 7:45PM.

Meals

Breakfast - All students will need to eat breakfast before they are dropped off the morning of the Field Trip. Breakfast will not be provided. Students are also encouraged to bring a water bottle and snacks for the bus ride.

Lunch - Students will eat lunch at SeaWorld Aquatica Theme Park. Lunch is included in the cost of the trip.

Dinner - Lunchable Meals will be provided for students to eat on the way home from SeaWorld.

Additional Information

Availability - There is a limited number of spots available for this Field Trip. Students will be accepted on a first come, first serve basis. Please submit the money and permission slip to the school office as soon as possible.

Cost - The fee of \$110.00, per student, can be paid to the front office by cash, check, or credit card. Field Trip Cost includes Admission into SeaWorld Aquatica Water Park, transportation cost to and from the school and SeaWorld Aquatica, and the cost of Lunch and Dinner Meals. Students may bring additional money for souvenirs and snacks (but this is not required).

Chaperones - Chaperones may attend this field trip. Chaperone Cost is \$110.00, each. Chaperones may travel via the Charter Bus with students.

Uniform / Items to Bring - Students attending this Field Trip MUST wear one of two options:

- **Option 1:** Gray CougarNation Cornerstone T-Shirt with shorts or **Option 2:** Student's Class T-Shirt with shorts.
- Students should wear their swimsuit to school, under their clothes. This is a water park.
- Bring a towel, sunscreen, and water shoes in a weatherproof bag.
- Bring a change of dry clothes to change into after the water park.

Annual Pass - If a student or Chaperone has an annual pass for Aquatica, the cost will be \$80.00.
